# **RECOMMENDATION:**

Approve the regular Board meeting schedule for the Arroyo Grande Tourism Business Improvement District (AGTBID) for the 2025 calendar year pursuant to Board <u>By-Laws</u><sup>1</sup>.

## IMPACT ON FINANCIAL AND PERSONNEL RESOURCES:

Approving a regular AGTBID Advisory Board meeting schedule for 2025 will not impact financial and personnel resources.

## BACKGROUND:

In adherence with the <u>by-laws</u> set forth by City Council requiring 'regular Board meetings shall be held at least quarterly according to a schedule established by the Board at the beginning of the calendar year', a meeting schedule for the 2024 AGTBID board meetings was confirmed on <u>September, 2023<sup>2</sup></u> for meetings held in 2024. The meeting schedule was determined to be held at City Hall bi-monthly on the third Tuesday at 3pm.

## ANALYSIS OF ISSUES:

The AGTBID Board meetings going forward are proposed to move from the Conference Room at City Hall to the Council Chambers, located at 215 E. Branch Street allowing a more accessible facility for the Board Members and the public pursuant to Section 11.a of the Board's by-laws. Due to current scheduling at the Council Chambers, the AGTBID meeting will need to be held one hour earlier to allow sufficient time for all business items to be considered.

## ALTERNATIVES:

The following alternatives are provided for the Board's consideration:

- 1. Approve the proposed regular AGTBID Board meeting schedule for calendar year 2025;
- 2. Modify and approve the schedule; or
- 3. Provide alternative direction to staff.

## ADVANTAGES:

- 1. Moving the meeting location to Council Chambers will provide greater access to meeting attendees;
- 2. Moving the meeting to an earlier start time will allow Board members to consider agenda items without time constraints; and
- 3. Moving the meeting location and start time will allow the Board to see members of the audience while also being able to see presentations.

#### DISADVANTAGES:

No other disadvantages are known at this time.
