Please accept this written letter as a formal protest against the Proposed Solid Waste Increase by South County Sanitary Services scheduled to go into effect on June 15, 2022 by us, Michael and Melissa Blanchard, as homeowners of [REDACTED], Arroyo Grande CA APN # [REDACTED].

These proposed rate increases and reasoning outlined in the Property Owner and Tenant notification letter are irresponsible to foist upon us taxpayers given the current global, national and local economic situations. Additionally, collecting a proposed 5.12% "temporary" surcharge for the duration of *six (6) months* to cover the delay in anticipated revenue for from *six (6) weeks* is unconscionable and a complete overstep of your authority. We vehemently protest this temporary surcharge especially, as well as the overall proposed rate increase in its entirety.

a. 5.88 % CAPITAL INVESTMENT COSTS?

b. 6.20% EQUIPMENT INVESTMENTS & ESCALATING EXPENSES?

c. 5.63% MARKET WAGE ADJUSTMENT?

d. 1.88% COMMINGLE PROCESSING FEE?

e. 2.60% OPERATIONAL EXPENSES?

f. 5.12% DELAYED RATE IMPLEMENTATION?
