Community involvement:

I have been volunteering for non-profits and "good causes" since my early adulthood. Most of these activities took place in Denver where I was involved in numerous non-profits but a favorite was The Park People, a foundation that raised money to refurbish Denver's parks. I was vice-president when we moved to San Francisco. There, I was involved in a number of civic projects and non-profits but the main one was the ARCS (Achievement Rewards for College Scientists) Foundation, Inc., an organization that raises money to fund meritorious Ph.D. candidates in the sciences in the major Northern California universities and where I served in most offices and as president for two years. The group had 200 members at the time and creates a million dollars a year for this purpose.

Arriving in Arroyo Grande several years ago, we had hardly had a chance to settle in before the lockdown stuck which has limited the opportunities. I did however initiate a newsletter for our homeowners' association and we have been frequent donors for several critical non-profits in this time. I am looking forward to more participation in this arena.

Background:

I have a B.A. degree in education from the University of Denver and taught in the Denver schools for one year before being retired by my children. Later, I did reporting for The Denver Post for six years covering the City of Aurora where I later became the Community and Media Relations person for ten years. After that, I formed a public relations consultancy firm with two partners and worked there until our move to San Francisco in 1989.

I think my long participation in non-profits of all kinds lends an appreciation of their work and their challenges.
